**STALLION SERVICE CONTRACT**

This is an agreement wherein \_\_\_\_\_, hereinafter referred to as the mare owner, has engaged Cotton Creek Farm (William J. or Judy Smith), hereinafter referred to as the breeder, for one service to their stallion **T J Sonny (Reg. # 249655)** for the mare \_\_\_\_\_, Registration No. \_\_\_\_\_ for the **2005** breeding season at a fee of \$ **500.00**.

The agreement of the parties are as follows:

**I. The mare owner agrees to:**

- Have the mare halter broken and in healthy condition. Any horseshoes on the back legs of the mare must also be removed.
- Furnish a photostat copy of the mare’s Registration Papers.
- Furnish a Negative Coggins test result dated within six (6) months immediately prior to breeding date. Shots required on current health certificate are Sleeping Sickness, Tetanus, Flu, Rhinopneumonitis, and Distemper before entering the farm.
- Allow the breeder’s veterinarian to check the mare for normal breeding conditions, and to perform such other veterinarian services as the breeder deems necessary at the mare owner’s expense. This includes, but is not limited to, treatment for sickness and/or injury.
- Pay the sum of any and all charges including mare care, veterinarian expenses and stallion service fees when the mare is picked up.
- Not hold the breeder responsible for any disease, injury, sickness, or death to the mare owner’s mare and/or foal.
- Pay the mare care charge of \$ **10.00** per day for dry mare, or \$ **12.00** per day for wet mare.
- Have the mare vet checked no later than \_\_\_\_\_. If the mare is not in foal, and a letter by the mare owner’s Veterinarian is sent to the Cotton Creek Farm stating she is not in foal by \_\_\_\_\_, the stallion fee will be refunded to the mare owner. If notification is not made from the mare owner by the date shown, it will be assumed the mare is in foal and there will be no refunds of stallion fees. There will be no rebreed on open mares past this date.
- Continue to breed mare through all cycles during normal breeding period of February 1 through June 30 or no refund of stallion fees will be made, and no rebreed will be done.

**II. The breeder agrees to:**

- Not hold the mare owner responsible for any disease, injury, sickness, or death to the breeder’s animals, property, or personnel.
- Provide a Breeder Certificate upon notification of the birth of a live foal, providing all conditions outlined in this contract as agreed upon by the mare owner have been met.

**III.** It is agreed that should the mare die, become unfit to breed, or is sold prior to the foaling from this breeding, this contract is null and void, and no guarantees or obligations will be honored.

**IV.** The live foal guarantee for this breeding will be, if the foal is born stillborn, lethal white or does not stand and nurse within 24 hours and death is certified by a Veterinarian then a return breeding, only for the season in which the foal was born, will be offered for the same mare. The mare owner will only pay for mare care and veterinarian expenses. There will be no live foal guarantee on the rebreed. The mare owner will remain bonded to the above terms of this contract.

**V.** The color guarantee for this breeding will be, if a solid foal is born from this breeding a return breeding, only during this season in which the solid foal is born, will be offered to the same mare or any one mare owned by the mare owner for 50% of the stallion fee in the year of the rebreed. There are no transfers of ownership on the rebreed. There will be no color guarantee on the rebreed. The mare owner will remain bonded to the above terms of this contract for the rebreed.

**VI.** This agreement will be a binding contract on both parties when signed by both parties and returned to the breeder.
